#### Message From Chief Nelson Genaille - TLEC President



ansi! On behalf of the Treaty Land Entitlement Committee (TLEC) of Manitoba's Board of Directors, I am honoured to provide greetings for this Progress Report.

I also want to thank our Member Entitlement First Nations (EFNs) for their continued support in my service as TLEC's President. I was honoured and extremely humbled to be selected again to serve as President at our 2020 Annual General Meeting (AGM) last July.

I hope this message finds you, your families and your communities well during these extraordinary times.

On behalf of the TLEC, we offer our sincere condolences to those families who have lost their loved ones to the COVID-19 virus.

2020 has definitely been an unforgettable and unique year. Not only have we witnessed and are still living through a global pandemic, but we've also observed and acknowledged the Province of Manitoba's 150th anniversary.

The TLEC is a stand-alone, rights-based organization whose primary objective is to help our Member EFNs secure their Reserve land entitlement under their Treaties with the Crown in right of Canada.

To achieve this goal, the MFA was signed on May 29, 1997, by the TLEC, Canada and Manitoba to provide a total of 1.1 million acres of Reserve land to our Member EFNs.

24 years later, over **562,000** acres has been set aside as Reserve by Canada under the MFA, in spite of Canada's consultation process with non-MFA Aboriginal groups, which we still oppose.

By the time you have the opportunity to read this report, our Federal Court of Canada application will have been heard by a judge.

Recall that we filed this Federal Court action on February 20, 2019, seeking a declaration that the Releases and Indemnities signed by each of TLEC's Member EFNs in favour of Canada, as required under the MFA, are void and ineffective, and that Canada is barred from relying on these Releases and Indemnities.

The reason for this legal action is that Canada failed to remedy its Events of Default, or breaches, of the MFA, as determined by an independent adjudicator in a 2018 Binding Arbitration Award between TLEC and Canada.

This is the first time ever that a party to the MFA has been found to be guilty of breaching this Treaty implementation agreement. And this breach continues.

#### Message From Chief Nelson Genaille - continued

The breach is that Canada failed to secure the written consent of TLEC's Member EFNs that would amend the MFA to allow Canada to consult other non-MFA Aboriginal groups on the TLE Reserve creation process.

Section 40.07, Amendment, within the MFA states:

"This Agreement shall not be varied or amended except by written agreement of the parties."

If the declaration is granted by a judge, this would clear the way for the TLEC to sue Canada for loss of use under the Treaty land claims process.

In 1997, when our Member EFNs agreed to accept the MFA's deal for land to settle their outstanding TLE claims, each EFN was required to provide Canada with a conditional release where they agreed that further legal action would not be pursued by them regarding Canada's failure to provide the Reserve lands that the EFNs were supposed to receive after their Treaties were signed.

This release however was not absolute. It was conditional. TLEC's original negotiators ensured that if during the implementation of the MFA, and if Canada was to ever breach its legal obligations under this three-party land claim agreement, an EFN could then ask a judge to set aside the Release. And this is the case with our current legal action.

As I mentioned earlier, TLEC hosted its 2020 AGM on July 23 and 24, 2020, on the Swan Lake First Nation's Reserve land in Headingley, Manitoba.

In addition to conducting our AGM business, we also paid tribute and honoured our out-going Elder Advisor, Mr. Jimmy Hunter Spence of the Nisichawayasihk Cree Nation (NCN), formerly known as the Nelson House First Nation.

Mr. Hunter Spence served the TLEC in his role as Elder Advisor since June 2011. He was no stranger to the TLE process, as he was also an elected Councillor of the NCN when they signed their Treaty Entitlement Agreement, under the MFA, in July 1998.

We again thank him for his dedication and guidance to the TLEC and the Board.

I also want to acknowledge and thank two (2) of our current longserving employees of the TLEC:

- Mrs. Linda Reimer, TLEC Implementation Advisor (2009 current); and,
- Mr. Chris Henderson, TLEC Executive Director (2010 – current).

#### Introduction:

#### The Manitoba Framework Agreement On Treaty Land Entitlement

n May 29, 1997, the Manitoba Framework Agreement (MFA) on Treaty Land Entitlement (TLE) was signed between Canada, Manitoba and the Treaty Land Entitlement Committee of Manitoba Inc., on behalf of 19 Entitlement First Nations (EFNs), at the Opaskwayak Cree Nation, Manitoba.

The MFA outlines how the Parties – Canada, Manitoba, TLEC and the EFNs - have agreed to fulfill the outstanding TLE obligations in Manitoba arising from the Numbered Treaties. It sets out the principles, responsibilities and dispute resolution processes associated with the land selection and acquisition process.

The MFA provides for up to a total of 1,100,626 acres of additional Reserve land to be selected and/or acquired for those EFNs that agreed to accept the MFA's terms through community approval process votes.

Of the 1,100,626 acres, 985,949 is the Crown Land Amount to be selected and 114,677 is the acreage amount to be acquired, or purchased, by the six (6) EFNs who were provided with land acquisition payments due to insufficient amounts of available Crown Land to select from within their territories.

Shortly after the signing of the MFA, Canada recognized the O-Pipon-Na-Piwin Cree Nation and the Marcel Colomb First Nation as separate First Nations under the Indian Act. As a result, both these First Nations are now eligible to sign on to the MFA and receive additional Reserve land.

One of the unique aspects of the MFA is the Implementation Monitoring Committee (IMC). The IMC is generally responsible for facilitating the implementation of the MFA and any Treaty Entitlement Agreement (TEA) signed by the EFNs, by monitoring and reporting on progress, making recommendations to facilitate implementation and assisting the MFA parties in resolving matters and issues in dispute.

The IMC is made up of five (5) members: two (2) representatives appointed by TLEC, one representative for each of Canada and Manitoba and an Independent Chairperson.

TLE refers to land owed to certain First Nations under the Numbered Treaties in Manitoba signed by the First Nations and the British Crown between 1871 and 1910.

Treaties 1 to 10 provided that the Crown would set aside a certain amount of Reserve land based on the populations of the "Indian bands", shortly after the Treaties were signed.

Not all Indian bands received their land entitlement as promised and cited as the "Per Capita Provision" in the Numbered Treaties; and this is what is referred to as "Treaty Land Entitlement".

#### TLEC'S Implementation Responsibilities

As set out in Article 33.02, <u>General Responsibilities of TLE Committee</u>, of the MFA, TLEC will assist with the implementation of the MFA and each TEA signed by TLEC's Member EFNs, by undertaking the following:

- 1. To provide technical and professional support to an EFN in planning and conducting the Community Approval Process (CAP);
- 2. To develop and deliver a communications program for the EFNs informing them about the implementation of the MFA;
- 3. To provide professional and technical support to an EFN in explaining the provisions contained in the MFA and the TEA and in the implementation of both agreements;
- 4. To establish a working relationship with the departments and staff of Canada and Manitoba in support of the implementation of the MFA;
- 5. To provide professional and technical support to an EFN <u>in all aspects</u> of the Selection or Acquisition of land to be set apart as Reserve, including:
  - a) Reviewing and commenting on the Land Selection Study undertaken by the EFN;
  - b) Liaison with Manitoba in the process of review of proposed Dispositions and Mineral Dispositions within each EFN's Community Interest Zone (CIZ);
  - c) Reviewing the application of the Principles to the Selection or Acquisition of land;
  - d) The preparation and negotiation of agreements necessary for the Selection or Acquisition of land;
  - e) The monitoring of the land transfer process;
  - f) The monitoring of the process of setting apart land as reserve;
  - g) The negotiation of municipal development and services agreements as required;
  - h) The removal, discharge or accommodation of Third Party Interests;
  - i) To provide professional and technical support to the Implementation Monitoring Committee (IMC) at meetings and aiding in resolving and mediating disputes amongst the major parties involved.
- 6. To produce documents and manuals in support of the implementation of the MFA; and,
- 7. To produce reports on the progress of the implementation of the MFA and TEAs.

#### Implementation Update

During this past fiscal year, and despite the global COVID-19 pandemic and its associated challenges and risks, TLEC continued to use its best efforts in working with Canada and Manitoba under the Three Party Strategic Planning Process, and assisting the EFNs in advancing their TLE parcels under this multi-step process.

The end goal of this collaborative effort, which is chaired and facilitated by the Independent Chairperson of the IMC, is to create Reserve lands.

TLEC also continued to support and assist the EFNs in their efforts to resolve and accommodate the various third party interests, and other encumbrances, on their TLE land selections and acquisitions by providing them with dedicated funding through the Third Party Interest (TPI) Account.

An example of a third party interest is a mining claim, mineral exploration license, a hydro distribution line and a lodge.

With respect to new TLE Crown Land Selections being made by the EFNs and Canada's unilateral consultation process, the EFNs have been reluctant to make new Selections due to the uncertainty and lack of rigor regarding Canada's current consultation process with non-MFA Aboriginal groups.

The EFNs believe that any new Selections may ultimately be prevented from becoming Reserve if a non-MFA Aboriginal group opposes the Selection.

As a result, the EFNs are awaiting to see the outcome of the TLEC's legal action against Canada in the Federal Court of Canada, which stems from the 2018 Binding Arbitration Award between TLEC and Canada.

On July 23 & 24, 2020, TLEC's Annual General Meeting (AGM) was held on the Swan Lake First Nation's Reserve Land in Headingley, MB.

Only 14 out of 15 Voting Member EFNs attended this AGM. The Mathias Colomb Cree Nation did not attend.

Presentations included the following: TLEC's Year-end Financial Statements ending March 31, 2020 by Heartland CPA, and year-end reports by TLEC's Implementation staff.

The TLEC Voting Members also elected a new Board of Directors for the TLEC.

The following individuals were elected to the TLEC Board for a two year term (2020-2022), as well as being appointed to the following TLEC Executive Committee positions, pursuant to TLEC's By-Law No.1:

Invited guest presenters at this AGM, included:

- Representatives from the Treaty One Development Corporation;
- Mr. Geoff Sarenchuk, Director of Consultation and Reconciliation Branch, on behalf of Honourable Eileen Clarke, Manitoba's Minister of Indigenous and Northern Relations; and,
- Mr. Laren Bill, Independent Chairperson, of the Implementation Monitoring Committee.

Representatives from Indigenous Services Canada, Manitoba Region, were invited to attend and present as well. Regrettably, Canada declined this invitation to attend citing the COVID-19 restrictions for federal government employees.

TLEC's outgoing Elder, Mr. Jimmy HunterSpenceoftheNisichawayasihk

Cree Nation, was also honoured for his services and steadfast guidance to the TLEC Board of Directors in a special Honouring Ceremony at this AGM.

During this past fiscal year, significant progress was made on the Northlands Dene First Nation's (NDFN) IMC Referral on the Reasonable Use Area (RUA) for lodges and outcamps, which affected their five (5) Crown Land Selections.

After numerous meetings and discussions amongst the MFA parties and the NDFN Chief and Council, the main RUA issue has been resolved to the satisfaction of the NDFN.

However, this referral will remain active until these Selections are set apart as Reserve by Canada.

With respect to TLEC's 2007 Hydro Easement Agreement IMC Referral, this matter was not referred to a formal dispute resolution process due to time constraints this past fiscal year.

As a result, this will be carried over into the new fiscal year and TLEC intends on advancing this Referral to its preferred dispute resolution process: binding arbitration.

There are 76 TLE Selections impacted by this issue for six (6) EFNs, representing over 89,000 acres.

I have been in this position since April 2010, and I am also one of TLEC's Representatives on the Implementation Monitoring Committee (IMC).

Since 2008, TLEC has operated under an annual Contribution Funding Arrangement (CFA) with Canada through its formerly named Department of Aboriginal Affairs and Northern Development Canada and now called Indigenous Services Canada. This funding relationship has allowed and enabled TLEC to continue fulfilling its TLE implementation responsibilities, as well as continuing to serve and represent its Member EFNs.

24 years after the signing of the 1997 MFA, Canada has set aside over 562,000 acres of land as Reserve for our 15 Member EFNs, in spite of Canada's consultation process with non-MFA Aboriginal groups.

TLEC's Member EFNs continue to object to Canada's unilateral consultation process, which has been deemed an Event of Default by an independent adjudicator in a 2018 Binding Arbitration Award between TLEC and Canada.

To date, Canada has not remedied this Event of Default and continues this breach by implementing its unilateral consultation process without the explicit written consent of TLEC's Member EFNs.

In accordance with Article 33 of the MFA, TLEC's Implementation Secretariat focused on the following priority areas in the 2020-2021 fiscal year:

- Continued participation in the Three Party Strategic Work Plan Process and assisting the EFNs in advancing their TLE parcels under this plan;
- Convening and participating in regular Parcel Review Meetings with the EFNs, Canada and Manitoba;
- Continuing to support and assist the EFNs in their efforts to address, resolve and accommodate the various third party interests and encumbrances on their TLE Land Selections and Acquisitions;
- Continuing to support the Barren Lands First Nation in their efforts to finalize their Land-in-Severalty Implementation Agreement;
- Continuing to assist the Buffalo Point First Nation's Birch Point Provincial Park TLE Selection

post-binding arbitration (2016) decision process;

- Assisting the Northlands
   Denesuline First Nation in its
   Referral to the IMC for resolution of Manitoba's Reasonable Use
   Areas for lodges and outcamps, which affects five (5) of their TLE
   Crown Land Selections;
- Advancing TLEC's 2007 IMC Referral on Hydro Easements to a formal dispute resolution process under the MFA;
- Encouraging and assisting those specific EFNs in making new Crown Land Selections, to the extent possible;
- Supporting TLEC's
   Representatives on the IMC and
   completing TLEC's undertakings
   under the IMC's 2020-2021
   Work Plan;
- Any other implementation issues and matters in dispute identified as priorities by TLEC's EFNs; and,
- On-going implementation of an external communications strategy that includes production of TLEC newsletters and annual reports, updating TLEC's website and Facebook page, and participating in the Treaty Relations Commission of Manitoba's Speakers Bureau.

As stated earlier and to date, Canada has not remedied its 2018 Event of Default and continues to be in breach of the MFA, which TLEC continues to oppose.

That being said, TLEC will continue to use its best efforts in all other tasks related to the land transfer and Reserve creation process mandated by the MFA and assisting our EFNs in advancing their TLE parcels under the Strategic Planning Process.

As continue we our **Treaty** implementation work, 2021 mark the 150th anniversary of the signing of Treaty No.1 (August 3rd). Our only Member EFN that is signatory to Treaty One is the Brokenhead Ojibway Nation. And we salute them in advance of this historical milestone as they continue to implement the Spirit and Intent of their solemn Treaty relationship with the Crown governments.

In closing, I thank the TLEC Board for their leadership and guidance and the TLEC staff for their dedication and work in assisting our Member EFNs during the COVID-19 global pandemic.

This has been a difficult year due to the pandemic and I found it hard

to assist my TPI Coordinators in the usual way. There were interruptions of lockdowns in their workplaces, however together we have managed to achieve some of the goals of the First Nations.

I am pleased to report that progress was still made for my assigned Entitlement First Nations:

- Bunibonibee Cree Nation has worked diligently and has selected almost of their total land quantum and most of this land has been set aside as Reserve;
- Northlands Denesuline First
   Nation had 11 Reserves created
   this fiscal year. In addition 5
   RSMs have been prepared and
   have been sent to Northlands for
   their signature. These Selections
   can now proceed to the next
   steps in the Reserve creation
   process. One parcel has unique
   issues and the parties are
   negotiating the resolution of
   these issues;

- Norway House Cree Nation made a new Selection for an economic development opportunity;
- God's Lake First Nation made a new Selection to pursue and enjoy their traditional activities on this parcel;
- Opaskwayak Cree Nation is making progress in acquiring a new parcel for economic development purposes; and,
- War Lake First Nation has signed 3 RSMs for 7 of the Selections in the Town of Ilford, and are negotiating the resolution of the TPIs for the other 4 Selections.

I continue to update the Annual Work Plans, which identifies the individual detail steps for each party, and the inter-dependence that each party plays. The Annual Work Plan is the guide for all MFA parties to track and monitor the progress of the selections and acquisitions.

In spite of all our frustrations dealing with TPIs and the delay in consultation, we will work together to ensure that future generations will inherit what was promised to them under the Treaties. We will assist one another in moving forward to have our lands set apart as Reserves.

First of all, I would like to extend warm

greetings to the Entitlement First Nations (EFNs) of the Treaty Land Entitlement Committee (TLEC) of Manitoba Inc. As we are all aware this past year has been most challenging during these ill-fated times as our world is being impacted by the global pandemic caused by the Coronavirus (COVID-19). In the midst of it all, I am honoured to continue provide support to the best of my ability to my assigned Entitlement First Nations (EFNs): Brokenhead Ojibway Nation, Manto Sipi Cree Nation, Nisichawayasihk Cree Nation, Rolling River First Nation and Sapotaweyak Cree Nation.

My role is to assist my assigned EFNs with the implementation of their respective Treaty Entitlement Agreements. I attend all party parcel review meetings and support meetings with the EFNs along with Manitoba and Canada where current updates are provided, and focus is on the methods of resolving Third Party Interests that

encumber their TLE land selections and acquisitions such as Manitoba Hydro & MTS Utility Permits, caveats, municipal issues, hydro easements, Manitoba Infrastructure interests and mining claim leases/permits.

I also participate in the Strategic Planning Meetings along with my TLEC colleagues, Manitoba, Canada and the IMC Chairperson where the All Party Annual Work Plan and other tools are maintained to transfer land as effectively and quickly as possible to Reserve status.

Though the MFA implementation process is slow, progress has been steady and it is through the dedicated efforts of the EFN's respective Chiefs and Councils and the TLE/TPI Coordinators that progress can be achieved.

My encouragement is to all EFNs, the TLEC, the Government of Manitoba and the Government of Canada to continue on implementing the 1997 MFA on TLE in good faith and determination to transfer all selected and acquired lands to Reserve status for the benefit of our children's future.

I look forward to continuing this work and one day seeing the completion of converting all Treaty lands to Reserve status. Until next time, love, pray and support one another and mostly stay safe in your daily life journeys.
